Green Passport: A Gate towards the Normal Life: A Corpus Linguistics Analysis of East and West Media

Abstract:

Green passport introduced by many European countries to make situation normal. But the opposition posed some reservation on implementation of green health passport. Green passport is a technology that can track down people under supervision, which means they are under constant observation; as President Biden said that we have to protect vaccinated from unvaccinated. This research contributes to highlighting the green passport concept during the Corona pandemic. This research used articles from east and west publications from the year 2021. Antconc version 4.0 and Ant Tag contributed annotations to the articles. There were 10572 words in total in the corpus. The study uses Mautner's (2016) Corpus-Linguistics technique to conduct corpus-assisted critical discourse analysis. This study combines Baker's lexical category model of concordance with a Corpus-Linguistics approach. The keywords were taken with American reference corpus which were examined via the lens of CLA. The examination of corpus data revealed that western data was great in number against the eastern corpus. The keywords grouped into themes which enabled to get insight of the data. The result showed that maximum countries are in favour of green passport with little reservation. Almost all countries agreed that green passport is a key to open normal business in the world. But needed to create justice in accepting third world green health passport. All governments are making significant efforts to implement the green passport, regardless of the concerns the WHO. The study thus recommended to investigate more newspapers' articles so that the result would be more authentic. It is important to find out the implication of green passport on people and society along with alternatives.

I. Introduction

This pandemic is a boon for animals, environmentalists, and the wealthy elite. The victims are ordinary individuals worldwide who are compelled to stay at home, face travel restrictions, or obtain a green passport. Almost all-powerful nations will make the covid-certificate mandatory for travellers very soon. The COVID-19 pandemic has bolstered and justified a shift toward more intrusive and pervasive surveillance. This process is expected to have long-term cultural, political, and economic consequences, impacting and radically reshaping the structures of emerging societies and the lives of our affective state (Couch, Robinson, & Komesaroff, 2020). To restrict people from travelling is not a new phenomenon but has been deep-rooted in human history. According to Agamben (2005), governments have been given an exceptional amount of authority, and people's rights have been eroded or denied in obtaining this restriction.

Green (2013) emphasized two consequences of border closeness, the first of which is that changes to borders not only affect how people relate to a location but also reshape the physical locations that borders mark, unite, and divide. Second, the historical variety of the shape and function of borders has drawn the attention of border researchers. As border regimes change, the emphasis has therefore changed more toward how places, locations, and spatial relationships are being reclassified; in a sense, the research has shifted more toward changes in the ground beneath everyone's feet. She is interested in physical borders, but in this instance, Covid 19 is establishing a brand-new, digital border, which is an entirely novel phenomenon.

A recent study by Gostin et al. (2021) found that digital health passes can have both health and financial advantages. The progressive reopening of public spaces like gyms, restaurants, theatres, and movie theatres generates economic advantages. Additionally, the certificates might encourage people to get immunised rather than routinely testing themselves before participating in social events. These passports are known as Digital Green Certificates inside the European Union. If a person satisfies one of the criteria listed below, they can acquire the certificate, according to the European Commission: The three requirements identified by self-determination theory (SDT) are autonomy (a sense of meaning, volition, and control over one's life), competence (a sense of being able to accomplish one's goals and overcome obstacles), and relatedness (feeling cared for by others, trusted and understood). These three psychological requirements must be met in order to self-regulate and maintain behaviours that enhance health and wellbeing. The results point to the possibility that restrictions like domestic vaccine passports may have a negative impact on people's autonomy, motivation, and willingness to receive vaccinations (Porat et al., 2021). The above discussion about the restriction in travelling due to covid 19 forced to examines newspapers in the East and West of the 2021 year related to green/covid passports. The research is qualitative, with different combinations of approaches used. First, the data was retrieved from newspapers using Baker's concordance model (2008). The study examined articles of the two worlds by using Mautner's (2016) Corpus-Linguistics Methodology, a CDA approach.

A. Research Problem

Green passport or Covid-passport is a new concept to control people from travelling. Here in this study, total surveillance; under vigilance by the adaptation of green passport policy of the world to restrict the movement of the people is being analyzed. The gap is the implementation of a green passport to restrict the movement of the general public to reset the current world system. The study analyzed the media articles discussing Green/Covid passport for one year, 2021. Articles of Western and Eastern Newspapers of five countries each provided data.

B. Research Questions

- What are the methods used by countries to introduce the green passport around the world?
- Why is the green passport seen as a representation of normalcy or abnormality?

C. Objectives

Gain a comprehensive understanding of how states are implementing the green passport globally. This will provide a clear picture of the different methods and strategies used by different countries to address the challenges posed by the COVID-19 pandemic and facilitate international travel.

Evaluate the perception and significance of the green passport as a representation of normalcy or abnormality. This will provide insight into how the green passport is perceived by different individuals and how it affects their daily lives, including their freedom of movement and ability to travel internationally. Additionally, it will shed light on any potential ethical and moral implications of the green passport and its impact on society.

D. Significance

It is crucial to know about the new concept of a green passport after the covid-19. The study explores new methods of green passport implementation among different countries. Moreover, the study investigates outcomes of a green passport which halted the freedom of movement or open gate to normality. And to discovers the ultimate aim of a green passport through this study. II. Literature Review

The idea of a global village was once considered a positive development, but the emergence of the coronavirus pandemic has changed this perception. The pandemic has complicated the situation due to the ease of international travel, a global business environment, and favorable diplomatic relations between nations. According to Kantor and Kubiczek (2021), the closure of borders during the pandemic has hindered economic growth and made it difficult for both tourists and business travelers to continue with their activities. This highlights the need for the implementation of the Digital Green Certificate (Covid passport) as a complex worldwide effort. The outbreak of the COVID-19 pandemic has significantly impacted the availability of products and services (Obradovi et al., 2020). Rather than focusing on the danger of undocumented migrants spreading the virus, it is crucial to address the broader interconnected geography that led to this global disaster (Anderson, 2020).

A. Green Passport or Covid Certificate

An immunity passport, also known as a health pass or release certificate, is a document, either in paper or digital form, that proves the bearer has immunity to a contagious disease. Governments can use public certification as a measure to control epidemics. Initially, travel required a negative RT-PCR test result and a quarantine requirement. With the introduction of vaccines, many countries lifted the test and

quarantine requirements for fully vaccinated individuals. However, the regulations were set by individual states rather than through international agreements. On March 17, 2021, the European Union took the first step towards harmonizing travel regulations by launching The Digital Green Certificate, also known as the Covid passport. The European Commission's coordination of the project aims to unify legislation and provide equal treatment for visitors, which is a significant ethical consideration. (Kubiczek, 2021)

B. Working of Green Passport

According to the European Commission (EC), a Digital COVID Certificate is a digital proof that a person possesses either:

- been vaccinated against COVID-19
- received a negative test result or
- recovered from COVID-19

- Digital/ Paper certificate
- With QR code
- Free of charge
- In national language and in English
- Safe and secure
- Valid in over the world

D. Corona Virus Out Break

The story of Covid-19 begins in December 2019 with a mysterious illness causing death. It was later classified as a coronavirus and named SARS-CoV-2 (severe acute respiratory syndrome coronavirus 2) or COVID-19 by the World Health Organization. In March 2020, it was declared a pandemic by the WHO. As of now, Covid-19 has claimed 4.6 million lives, with 227 million reported cases and 58.74 million vaccinated people. The data is compiled daily by Johns Hopkins University, making it a credible source for Covid-19 information.

E. Concordance Modal of Analysis

The evaluation of concordances was used to identify significant lexis and lexical patterns in the research. Concordance analysis provides examples of a word or cluster in context (Baker, 2006). The analyst can adjust the number of words surrounding the word/cluster being analyzed and categorize the correlation lines to better understand patterns. This method allows for the examination of linguistic elements in context while also considering the analyst's understanding of the context deduced from the text.

III. Research Methodology

The research is qualitative, with a combination of corpus and CLA methods used. The first data was gathered from articles in the media on the Green/Covid passport using Baker's corpus linguistics model of concordance (2008). The data was analyzed using Mautner's Corpus-Linguistics Technique, a CLA approach (2016).

A. Research Tool

Deliberate sampling is a type of non-probabilistic sampling method where the researcher actively selects a sample from the population based on specific criteria. The sample is chosen with a purposeful intent, with the goal of including a certain type of unit or representative elements. Deliberate sampling is also referred to as purposive sampling, selective sampling, or criterion-based sampling. It is used when the researcher has a specific aim in mind, and the sample is selected to help achieve this aim. The sample size in deliberate sampling is often small, and the sample is not selected randomly. This method is often used when the population is small, and it is easy to identify the units that are of interest to the researcher. To gather information for the study, a deliberate sampling method was employed. The population for this research was comprised of five articles from both Eastern and Western publications, all of which were published in 2021.

B. Research Design

First, the data (articles from Eastern and Western newspapers) was collected systematically from various news websites using a purposeful sampling tool. Each of the five countries has been chosen to receive data for 2021. After that, the data was converted to plain text. The articles had a total corpus of 10572 words. AntConc, a software product version 4.0, extracts all data to obtain soft corpus data. After that the total corpus and the American reference corpus build in Antconc version 4.0 used to get the keywords. Further, the 22 keywords were grouped into five themes which were analyzed using Gerlinde Mautner's CLA Corpus-Linguistics Approach (2016).

C. Theoretical and Analytical Framework

Gerlinde Mautner's (2016) Corpus-Linguistics Approach provides a theoretical framework for this study. Baker (2008) model of concordance, and CLA analyzed the data.

D. Delimitation

The focus of the study was limited to publications about green/covid passports on news websites. The pieces were chosen from magazines and news websites in the East and West. Five countries have been chosen from each, as well as one newspaper from each. In 2021, one story regarding green passports was chosen for study from the newspapers.

IV. Data Analysis

Newspapers discourse is the pulse of the society. That pulse is raised or lowered by the government and powerful elites. Green passport is being considered compulsory for the welfare of the general public, that is how people's movement has been restricted. The articles of newspapers were collected from the two worlds, i.e., West world and East world analysed using Corpus linguistics analysis.

A. Western Newspapers and Frequencies

The Table 1 reveals that western newspaper articles have 7498 total corpora. The impactful major five western countries newspapers have been selected for this study. The most famous with large publication newspapers have opted for the analysis under the theory of CLA. France has highest 2072 words corpus, American newspaper has second highest 1830 frequency, and Canada is third highest with the 1288 corpus. United Kingdom and Australia almost have the same frequencies, 1155 and 1153 respectively.

Table 2 is about the details of Eastern Newspaper articles. The data of Eastern articles are almost half as compared to western articles. The Eastern writers are scrupulous and to the point. They are very choosey to using the words. The highest corpus of Japan times with 957 words, second Dawn newspaper, a Pakistani media outlet possessed 740 words article. Further, Daily China wrote articles with the total 572 words got third highest position in the corpus. The rest of two countries Turkey and India wrote almost in same numbers 357 and 430 respectively. This attitude showed that East is not so vocal about this new monster in the world.

B. Keywords List of the Two worlds Corpora and Reference Corpus

In order to extract keywords while taking keyness into account, this study chose the log-likelihood test. According to Scott and Tribble (2006), keyness is the importance of words in a text, the words that make up the text as a whole and reflect its features. It determines how much weight a word has inside a corpus and, in particular, ranks all keywords according to their keyness values. After everything was set up, a reference corpus (AmE06) and target corpora were compared in order to extract keywords. Once the reference corpus was added and the target corpus was uploaded, the keyword generation process began. It generated 100 keywords for this study, out of which I choose the top 22 in terms of their rating. I chose the top 22 terms that were significant to the green passport and were arranged by keyness value in descending order. In reality, the prominence of the keywords in the keyword list denotes the importance of the entire corpus, or, to put it another way, it indicates the "aboutness" of the text (Baker, 2008, Aluthman, 2018). As a result, terms were excluded based on their highest keyness value and relevance to the green passport. A total of 22 keywords were chosen because they were deemed sufficient for the purposes of this investigation and adequate for generalising about how the green passport was covered in east and west media.

C. Themes of the Keywords Extracted from the Corpora

The keywords were selected for additional examination in order to manually divide them into other thematically related groupings. This method of analysis makes it easier to see themes that have evolved in the corpora above the lexical level. Therefore, a keyword list acquired from corpora was grouped into five broad groups while following Baker (2008), Aluthman (2018), Gabrielatos and Baker (2008), and Kandil (2009). Based on their thematic associations, all of the terms in the keyword lists were assigned to one or more of the selected themes. The themes extracted from the keywords are; green, covid, vaccine, digital and travel. The following table 4.4 lists focused on themes and their related keywords.

The themes in the articles give an accurate picture of the writers' intended meaning. The following themes have taken from the keywords list because they are unique and essential in the articles since they revealed the writers' thoughts on the green passport. Furthermore, these themes are frequently associated with the concept of a green passport, allowing for a more vivid and straightforward explanation. The table 4.4 illustrates the keywords categorized into themes to get more general critical linguistic concordance analysis of the media discourse regarding green passport. The theme words extracted from the keywords; *Green, Covid, Vaccine, Digital, and travel*, are selected for concordance analysis.

D. Analysis of Theme 'Green' Concordance in the Western Media

The word "Green" appears in the Western articles, as shown in Figure 4.1. The west is more concerned about travel and is attempting to restrict unvaccinated individuals. They fear death; thus, most Western countries have issued green passports as protection. That is why they used the word "green" 32 times compared to only eight times

in Eastern publications. Some scholars think the covid-19 pandemic is a hoax to gather individuals for total surveillance.

E. Analysis of Theme 'Green' Concordance in the Eastern Media

Theme 'green' has 4 frequencies in the eastern media with two co-text, certificate and pass. The linguistic pattern is very unique in this concordance, the four lines concordance shows that this theme is used as a noun mostly in the eastern media. There is no single eastern country mentions a green passport in their country but western green certificate mentioned in the media discourse. Western scared more and have more resources to travel overseas; thus, applying for a green passport is not a hassle. Line 4 expresses the Indian response of EU policy towards selective vaccines in these words; *India took issue with the European Union plans to institute a green pass from July 1, with government sources warning that India will introduce a reciprocal policy only allowing ease of travel for those European countries that recognise Indian vaccines Covishield and Covaxin.*. Moreover, Denmark and Sweden are also looking to launch a green health pass to make ease the movement as proposed by EU in line 3.

F. Analysis of 'Covid' Concordance in the Western World

Covid-19 poses a threat to the entire world. All countries are using vaccination to help lessen the effects of covid-19. The western media has used the word "Covid" 29 times in the corpus. The west used "*covid*" in the articles in context; *covid-19, covid certificate, covid crisis, covid recovery, covid certificate, covid status* and *spot* etc. the benefit of the green certificate is to skip from the stressful quarantine of a person. Line 9 discusses that, *British citizens arriving from amber list countries were already able to get a "COVID pass" that allowed them to skip quarantine if they were fully vaccinated.* In almost all lines praised the initiative of the western countries of the introduction of the green certificate. Only line 13 disclose some opposition of the green passport in these words; *Labour's deputy leader Angela Rayner said the government's approach to Covid passports had been "shambolic from the start"*... She called it a shameful symbol to stop people movement.

G. Analysis of 'Covid' Concordance in the Eastern World

The east uses theme 'covid' 30 times with the co-text; 19, pass, passport, recovery, spot, and status. This theme is used as a noun in the concordance by the western media. Only four times the 'covid' theme with different co-text, other than the certificate. It means the concordance has 13 lines related to green passport or certificate. Which shows how important this document is. Most of the voices are in favour of covid-19 certificate but there are some opposite voices also in the western media discourse. The opposition tory MPs and Liberal Democrats ED Davey called green passport "divisive, unworkable and expensive". Furthermore, the sports organizations also try to introduce the covid-19 passport. The Manchester United declared Covid spot-checks on match days at Old Trafford to minimize the chance of spreading of coronavirus.

H. Analysis of 'Digital' Concordance in the Western World

In some ways, the linguistics analysis of 'digital' theme in western articles is similar to that in the east. Western writers have coined the terms "digital certificate," "digital pass," "digital passport," "digital signature," "digital immunisation certificate," and "digital green certificate," among others. Western writers used the word "digital" in their articles 27 times. They utilized words like digital covid certificate, digital app, digital application, digital health certificate, and so on. Compared to the west, the East has a limited understanding of e-learning. The traditional education and health care systems are still in use in the East. In comparison to the west, digitally generated documents are scarce. They have a higher level of digitalization than the east. That is how, eastern media mostly quoted western newspapers and organizations for digital green passport, as seen in line 2 of this concordance; *Britain NHS has also launched a digital application meant to serve as a vaccine passport.* As a result, digital words are employed about half as much in eastern publications as in western papers.

Theme 'travel' is used 36 times in the western media with the following co-text; *adding, and, associations, because, between, by, companies, does, Donald, entertainment, freely* and *has.* Stopping people from travelling is not new; nations and elites have tried to prohibit people from travelling who are not their favourites. The context is fascinating; *travel freely, join a travel association, work for a travel company, travel between and more,* and so on. WHO emergencies chief Dr. Michael Ryan was against the idea of green certificate and declared it against the ethics. Mostly countries including Australia to issue digital passport to allow travelling domestically. Line 9 reveals, *WHO cautions against vaccine passports for international travel.* But most of the countries and organizations are agreed with the proposal to implement the green passport for safe and sound traveling.

Eastern writers use this theme to highlights the importance of the traveling, because mostly eastern countries population are working in western countries. The only China eastern country who tries to launch a green passport but the western countries create problems in its application. Line 2 discusses that context in these words; the Chinese health passport is an attempt to make it easier for its citizens to travel abroad, but without recognition from other countries it is of little use. Japan is also doing the same as the China does, but the western showed cold response because of many reasons.

N. Discussion

V. Findings and Conclusion

It is unlikely to be eradicated. This study looked at reports from the West and East about green passports. It has been revealed that obtaining a green passport is unavoidable and that people will be vaccinated whether they are healthy to resume the normal life business. Without that green passport there is no freedom of movement or access to medical care. The western corpus is enormous against the eastern corpus because they have more knowledge about this novel virus and its vaccines. That is how the articles in the western media are almost half of the western corpus, e.g., 7498 western corpus and 3074 eastern corpora. Further, the five newspapers corpus of west, French newspaper Mondaq had highest 2072 frequency, while in the eastern corpus, Japan Times had highest 957 words frequency (see Table 4.1, and 4.2). The keyness of the data was very amazing, 'vaccine' had the highest keyness, i.e., 888.63, passport had 536.58 and covid 468.77, lowest keyness was registered that is 31. 76 with 'traveling' and so on (see Table 4.3 for details).

Apart from frequency, the data showed that one must accept the unpleasant reality and if wanted normalcy must get vaccination. European Union was looking in hurry to implement the green passport, that is how they tried first to introduce the new phenomena. They also set rules for the third world travellers to enter Europe get vaccination and secure the e-passport. Almost all countries in west were agreed that green passport was the only way to normalcy.

It is recommended for the scholars to make bigger corpus by including more articles and countries in the study. Researchers should investigate the implication of the green passport in the west and east on people and business. Moreover, researchers may find out alternatives of the green passport which would more helpful to poor countries and travellers.

The gist of the study was that the West would be the first to be vaccinated and obtain a green passport, followed by the developing countries, especially in the east. They had no choice but to embrace the West's order, a green passport. Finally, it is clear that there is green passport was only good solution to bring normalcy in the world for save and sound traveling. Green passport is necessary for the people who are traveling abroad especially western countries, because no green passport no traveling, that's it. Green passport is a way to eradicate abnormality created by the coronavirus. Green passport paved way to normal life and normal business.
